**911 EXECUTIVE DIRECTOR REPORT-** Executive Director Kim Tolliver reported on the following:

**CALL VOLUME REPORTS – NPSO** for the month of January, had 1631/ 911 calls, of which 56 were abandoned, giving them an actual total of 1575 911 calls taken. Abounded rate of 3.43%. They took 2125 inbound calls on their Administrative lines, of which 11 of those were abounded. They made 2574 outbound calls for a total of 4710 calls, giving a total 911 calls of 6341.

**NPD** for the month of January had 388/911 calls, of which 4 were abandoned at 1.03% rate. Giving them a total of 304 911 calls actually taken. On the Administrative lines they had a total of 2862 inbound calls/ 1049 outbound calls with 40 calls abandoned. for a total of 3951 calls on the Administrative lines, giving them an overall total of 4339 calls taken for the month.

Sheriff's office took 3 call from the call box. Police took 106 calls form the call box.

**NPSO**-Transferred 7 calls to Desoto Parish, 324 calls to NPD. Desoto Parish transferred 8 calls to NPSO and NPD transferred 11 to NPSO.

**2023**-NPSO took a total of 17.896 911 calls. In comparison to 2022, we took 19048 down 1152 calls.

**2023**-NPD took a total of 3825 calls. In comparison to 2022, they took a total of 4453 down by 628 calls.

**2023 BOARD ATTENDANCE**- Director Tolliver congratulated Commissioner Keel for perfect attendance, also thanked each Commissioner for their efforts to attend the Natchitoches Communication District meetings.

NPSO 911 calls processed-17896. NPD 911 calls processed-3825 total from both Agencies-21721. NPSO abandoned calls873. NPD abandoned calls 56. Total abandoned calls from NPSO-581 out of 597 called back. Total abandoned calls NPD-43 out of 43 called back.

**9-1-1 ADDRESS COORDINATOR REPORT**- During the month of December, 2023, the addressing office processed (5) new addresses for residence and (0) updates in the Parish in Natchitoches Parish. The activity resulted in (219.0) miles being traveled throughout the Parish consuming some (12.5) hours of personnel time while conducting site surveys and collections of GPS data. Upgrade any console equipment provided by the District that is end of life.

Continue to work with the APCO Legislative Committee in reaching statewide consensus on a path forward for implementation of the Louisiana state wide 9-1-1 plan.

Bring up third workstations with NPD

Bring up two extra workstations in the Comm Ctr

Prepare/Complete over haul of GIS system in preparation for next Gen (thereby reducing field time of driving)

#### **OPERATIONS**

In collaboration with NPD and NPSO Communications, EMS, and other appropriate parties, develop fire/EMS/law enforcement caller integration and asset deployment training for both agencies.

In collaboration with NPD and NPSO Communications and other appropriate parties, continue to develop a concept of operations (COO) plan to support the implementation of single point 9-1-1 call taking (option 2 as defined in the 2009 Communications consolidation and PSAP study, and approved by the Commission). Vital components of the COO will include:

- a. Detailed work load evaluation and analysis (base upon current task analysis)
- b. Detailed staffing evaluation and analysis (to determine the appropriate number of staffs to perform identified tasks)

Develop policy and procedures for dispatch operations.  
Continuity operations for the District (as outlined in Legislative Audit/Backup Facility  
Continue to focus on common professional development opportunities for each communications center agency  
Conduct a Communications center Supervisor Course for NPSO and NPD  
Generator transfer switch to run second stand-alone generator  
Possibly having new NATCOM partners in the Comm Center  
NGA/AT&T come out and assess center for prep in next Gen  
New Chairs for Comm Center  
Create a Strategic planning Committee to begin a new five-year outlook plan (NATCOM's 2025-2030 outlook)

Thanks to Commissioner Braxton for suggesting the CDARS CD's. It has created an avenue for us to have the ability to have those extra funds to further the 2024 Goals and Objectives in being able to purchase new equipment.

### **COMPLETED 2023 GOALS**

Communications Training Officer's Course  
Face-Lift/update the District's webpage (to include new design and the ability to self-initiate updates). Sign CE with the surrounding Parishes to begin the process for NextGen 9-1-1 in collaboration with NPD and NPSO Communications. Develop a path forward the implementation of minimum staffing requirements. (The people who operate our Emergency Communications Center provide the critical link between those who need help and those who can provide that help in emergency situations. It is critical that in times of emergency there are adequate numbers of these trained personnel in place in our ECC to adequately provide this service.)

**NSU-** Received a call on last Friday from Blayne Henson @ NSU to conduct a test for 911 purposes. Stated they were moving away from their old equipment and was now converting over to Microsoft teams app. SIP lines. Currently the city does not dispatch for NSU. Once in a blue moon they may get an occasional call. The questions posed were: Do we call the officer back and give him the information? Are we dispatching now? How is this going to work? All great questions that couldn't be answered. So, I have a meeting set up with them. I told him I would rather they wait until I can speak candidly to them. That I'm going to need more information and insight. He had already been working with Intrado. ALI only showed 200 Central Ave. NS of Louisiana, which is the main name for it hence problems already, now the other tricky part is because it is a SIP line which is similar to VOIP bring it be an internet base platform, when test it comes in as wireless meaning NPSO office captured the call. SIP means Session Initiation Protocol. It delivers calls via the internet IT support VOIP because it is internet base to internet outages. Not sure if they considered that. But calls can be rerouted to mobile phones or regular lines as BLU, but again, right now informational. They cancelled my meeting for tomorrow morning and I'll be meeting with them on the 31<sup>st</sup>.
